

The Standard outlines the responsibilities of the promoter in terms of assessing, managing and monitoring project impacts, risks, and opportunities related to Indigenous Peoples as well as persons or groups that are vulnerable, marginalised or discriminated against due to their socioeconomic characteristics.

7. Vulnerable Groups and Indigenous People


Addresses inequalities and other factors contributing to vulnerability, marginalisation and/or discrimination within the context of an EIB project;

Respects the rights and interests of vulnerable, marginalised or discriminated-against persons and groups, and Indigenous Peoples, including the right to nondiscrimination and the right to equal treatment between women and men

Fosters their effective participation in the design of project activities and mitigation measures by establishing an ongoing constructive relationship between them and promoters;

Promotes equitable sustainable development gains and opportunities for vulnerable, marginalised or discriminated-against persons and groups, and Indigenous Peoples.



Clarifying requirements regarding vulnerable groups: consistency of structure and language



*The promoter may be asked to supplement the formal engagement process carried out by relevant competent authorities, or otherwise needed in relation to the requirements set out in the other EIB Environmental and Social Standards whenever applicable, with any action deemed necessary by the EIB.

Requirements for projects affecting Indigenous Peoples are applicable to all projects, whether in the EU or outside the EU, where IPs are present in, or have collective attachment to a proposed project area or an area that will be negatively impacted by the project

Indigenous Peoples definition streamlined to refer exclusively to a **distinct** and/or **vulnerable** sociocultural group possessing all of the following characteristics:



Self-identification as members of a distinct ethnic or cultural group and recognition of this identity by others; and,



Collective attachment to geographically distinct habitats, ancestral lands, or areas of seasonal use or occupation, as well as to the natural resources in these areas and use thereof; and,



Customary cultural, economic, social or political institutions, laws or regulations that are distinct or separate from those of the dominant society or culture; and



A language or dialect, often different from the official language or languages of the country or region in which they reside.

Promoting the right to Free, Prior and Informed Consent (FPIC) where a project:

- affects the lands, territories or resources that IPs customarily own, occupy or otherwise use;
- relocates them from land and natural resources subject to traditional ownership or under customary use or occupation; or,
- significantly affects or exploits their cultural resources, whether tangible or intangible, or their ways of life.
